COURT ORDERED EDUCATIONAL PROGRAMS

In Oklahoma the law requires all adult parties who file for divorce on the grounds of incompatibility must attend an educational program prior to granting a divorce. Oklahoma County Court requires that the program be attended <u>in person</u>, not online, and a minimum of 4 hours. A certificate of completion provided by the program provider must be presented to the Court upon completion, by both adult parties, prior to your hearing date.

These program providers are not recommended or suggested by the court, as this flyer is for informational purposes only. The program providers below meet the requirements in OSA 43 §107.2.

PRE-ENROLL AND PAY YOUR FEE.

You may choose to take your class at one of the two locations listed below. Please do not mail in the enrollment form. All enrollments must be made in person (or by online registration at http://www.ccfinorman.org/divorce-and-co-parentingservices if you are enrolling with the Center for Children and Families, Inc.) at the agency that coordinates best with your schedule. The fee for the class is \$50.00 per person — see accepted payment methods below. If you have been declared indigent by the court, you will not have to pay the fee, but you must provide proof of indigency (pauper's affidavit) along with your enrollment form. Please make sure to indicate the date, time, and location of the class you are enrolling in at the top of the enrollment form. The class schedule is attached to this packet.

- CLASS SIZE IS LIMITED on a first paid/first served basis. Be aware that classes fill quickly.
- Enrollment form and fee must be received no later than 5:00 PM on the Thursday before scheduled class.
- There will be NO ENROLLMENT AT THE DOOR the day of the class. (NO WALK-INS)
- If you are unable to attend or need to reschedule, there will be a \$10 rescheduling fee.
- Children are not allowed in class. Childcare is NOT provided.
- Refunds are available for the class 6 months after original payment. Refund checks are distributed by mail or pick up. Refunds requests can take up to 2 weeks to process.
